



**LSVT GLOBAL announces the 2009 LSVT LOUD Training and Certification Workshop Series for speech-language pathologists.**

The LSVT® Training and Certification Workshop is a two-day program designed to train speech-language pathologists a voice/speech treatment technique for adults and children with motor speech disorders, with a specialty in Parkinson disease. The fundamentals underlying key treatment elements, efficacy data supporting treatment outcomes, details of treatment tasks, including hands-on practice, and practical considerations are taught. Application of the LSVT® to pediatric and adult motor speech disorders (e.g., multiple sclerosis, cerebral palsy, stroke) will be discussed. The impact of LSVT® on swallowing and pre-/post- LSVT® neural imaging data will be presented. This training is offered for 1.2 ASHA CEUs.

**Steps for Certification:**

1. Register for a two-day LSVT Training and Certification Workshop.
2. Complete two required pre-workshop readings; participants are responsible for information in these readings. **These readings will be sent as email attachments with your confirmation.**
3. Read and accept the non-compete/non-disclosure form, attendance and cancellation policies.
4. Attend the entire two-day LSVT Training and Certification Workshop
5. **Complete a Certification Exam with an 85% score required to receive certification.** The exam will be administered during the two-day training course. If a participant does not pass the examination, there will be an opportunity for a post-workshop learning task to complete the certification requirements.

### **Lorraine Olson Ramig, Ph.D., CCC-SLP**

Dr. Ramig received her doctoral degree at Purdue University and master's degree at the University of Wisconsin-Madison in communication disorders. Dr. Ramig is a Professor in the Department of Speech-Language and Hearing Science at the University of Colorado-Boulder, a Senior Scientist at the National Center for Voice and Speech (NCVS), a division of the Denver Center for the Performing Arts (DCPA), located in Denver, Colorado, and an adjunct professor at Mt. Sinai School of Medicine and Columbia Teacher's College in New York City. Dr. Ramig is an internationally recognized scientist with an established research record in the areas of aged and neurological voice disorders. She has been investigating neurological voice disorders for over 15 years and has authored numerous refereed journal articles and book chapters.

### **Cynthia Fox, Ph.D., CCC-SLP**

Dr. Fox received her doctorate degree in Speech and Hearing Sciences from the University of Arizona, Tucson. Dr. Fox is a research associate at the National Center for Voice and Speech, a Research Lecturer in the department of neurology at the University of Arizona, Tucson, and Executive Vice President of the LSVT Foundation. Dr. Fox is among the world's experts in speech treatment for people with Parkinson disease. She has multiple publications in this area of focus, as well as numerous national and international research and clinical presentations. Dr. Fox has worked closely with Dr. Ramig for the past 12 years on studies examining the efficacy of LSVT/LOUD, the underlying mechanisms of speech disorders in Parkinson disease, and the application of LSVT/LOUD to other disorders (children and adults) and other motor systems (e.g., limb).

### **Leslie Mahler, PhD, CCC-SLP**

Dr. Mahler received her doctoral degree at the University of Colorado and is an Assistant Professor at the University of Rhode Island. Dr. Mahler conducts research in the area of behavioral treatment of motor speech disorders and the application of LSVT<sup>®</sup> to individuals with Parkinson disease as well as other neurological disorders. She has 30 years of clinical experience treating adults with neurological disorders. Dr. Mahler was a member of Dr. Ramig's research team at the National Center for Voice and Speech prior to joining the faculty at the University of Rhode Island.

### **Angela Halpern, M.S., CCC-SLP**

Ms. Halpern is an ASHA-certified speech language clinician and research associate at the National Center for Voice and Speech in Denver, CO. She received her master's degree in the Department of Communication Disorders and Sciences at the University of Pittsburgh. Ms. Halpern has worked extensively in the area of neurogenic disorders with a specialty in Parkinson disease. She is certified in the LSVT<sup>®</sup>. In addition to providing speech therapy to individuals with Parkinson disease, she is a faculty member and workshop leader for the LSVT Global. She is also a member of Dr. Lorraine Ramig's research team. As a part of this team she continues to study voice and speech in Parkinson disease.

### **Jill Cable, M.S., CCC-SLP**

Ms. Cable is an ASHA-certified speech language pathologist. She received her master's degree in Speech-Language Pathology at the University of Arizona in Tucson. An LSVT certified speech-language pathologist will be able to:

- Use the LSVT efficacy data to market and support reimbursement of LSVT programs
- Enroll in the database of LSVT Certified clinicians for patient and physician referrals
- Subscribe to the LSVT listserv
- Audit future LSVT Training and Certification Workshops for reduced fees

## ***LSVT® Certification Renewal:***

LSVT® Certification requires a bi-annual renewal. The process of LSVT Certification renewal will be primarily web-based and involve the following steps:

- Complete an LSVT continuing education activity (provided via web-based reading/video/exam)
- Document use of LSVT® (survey questions related to number of patients treated and general treatment outcomes)
- Provide updated contact information for patient referrals
- Pay renewal fee
