25 26 27 28 29 30 31 32 33 34 35 36 37 38 39 40 41 42	Committee Reports:	Select Committee on the Distribution Requirement Professor Marten denBoer, Chair of the Committee, presented the resolution concerning the transfer credit evaluation process. This proposal would allow a departmental advisor to determine that a particular course at another college, while not a direct equivalent of a specific course at Hunter, could be used to satisfy a distribution requirement if the course satisfies the general objectives of the distribution requirements. Some departments already do this, but the practice is not universally known. For example, an advisor in Physics could certify that a course taken in the Physics Department at another college could be used to satisfy a Category I requirement, even though the course was not equivalent to a specific course offered by the Physics Department at Hunter. Such a determination would not imply acceptance of the course as a prerequisite for other courses; the determination of course equivalents that may be used as prerequisites would remain where it is, with each department. The option to grant substitutions for distribution credits should be an explicit part of the Office of Admissions' transfer evaluation form. Such decisions, once made by a particular department, will be used by the Office of Admissions to update the student data base, so that subsequent students transferring the same course from the same institution will automatically receive the same distribution credits.
43 44 45 46		BE IT RESOLVED, that the Hunter College Senate approve current practice and officially authorize departments to grant distribution credits for transferred courses which have no direct Hunter equivalent, but satisfy the general objectives of the distribution requirement; and,
40 47 48 49		BE IT FURTHER RESOLVED, that the Office of Admissions' transfer credit evaluation form be modified to include the option to grant distribution category credits for transfer courses.
50 51		After discussion it was moved that the resolution be amended by adding the following:
