Applying for a New York or New Jersey Driver License or Non-Driver ID Card

Bring the following original documents with you along with a set of copies to provide to the DMV worker.

- U.S. Social Security Card bearing your signature. **2 points**
- Social Security Administration letter of Ineligibility **0 point**

Social Security Card can only be obtained if you have an employment offer. If you do not have a Social Security card, you must obtain a social security administration letter of ineligibility from the social security office and present it along with the following items at the DMV office. - Passport (valid for at least 6 or more months) with F-1/F-2 visa or F-1/F-2 status approval form, I-94 along with a SEVIS I-20 (you must have at least six months left on the SEVIS I-20) containing a stamp obtained at the airport by a U.S. Department of Homeland Security. It is advisable to carry all your SEVIS I-20s with you when you go to the DMV office. **3 points, NY** **4 points, NJ**

In addition to the aforementioned documents you will need to have one or more of these items below to make up the six required points:

- U.S. college/school photo ID and transcript (official one recommended) **2 points**
- Valid photo driver license issued by another U.S. state or Canadian province **2 points**
- A supermarket check cashing card **1 point**
- U.S. health insurance card, prescription card **1 point**
- NY utility bill with your name on it **1 point**
- U.S. bank statement, canceled check with your name, ATM card, or valid major U.S. credit card. **1 point**

DMV requires all original documents and will not count more than one document of the same type of proof. (For example, 3 major U.S. credit cards are viewed as one card). Your full name must be the same on all documents presented. Altered or erased documentation will not be accepted and may be confiscated for further evaluation. All fraudulent documentation will be seized and may result in criminal prosecution.
