Research Dean On Campus

We wish to warmly welcome Dr. Herbert F. Budd who has assumed duties as the Dean of Research at Hunter College, effective Feb. 1, 2000. Dr. Budd holds the *Docteur-es-Sciences Physiques* from *Ecole Normale Superieure*, Paris and Master's and Bachelor's degrees in Electrical Engineering from the Massachusetts Institute of Technology.

He most recently served as President of the Atlantic Business Corporation which specialized in natural language application development with a special focus on information technology and telecommunications. Dr. Budd also served as General Manager of Global Business Intelligence Solutions Unit in Paris where he led the IBM World Wide development and marketing introduction of text and natural language. Prior to that he was a General Manager of Scientific, Technical and Education Industries in Paris where he was responsible for the first IBM business unit covering industrial research and development, public research and universities.

In addition, Dr Budd served as European Director of Scientific and Technical Computing for Paris/Rome and was responsible for high performance computing and networking in Europe, the Middle East and Africa and the entry of IBM in the supercomputing market worldwide. Dr. Budd also was responsible for scientific and technical programs in Europe, the Middle East and Africa and initiated major European partnership programs with leading research groups.

In New York, Dr. Budd worked at the C.N.R.S. U.S. Mission and was responsible for relationships and negotiations for research and education with US Federal agencies.

We wish Dean Herbert Budd a long and successful tenure at Hunter College.

Also On Campus

We wish to also welcome to campus the new Director of Centro de Estudios Puertorriqueños.

Dr. Felix V. Matos Rodríguez assumed duties as Director of Centro on February 1, 2000. He has also been appointed to the Department of Black and Puerto Rican Studies as a tenured Associate Professor. Dr. Matos Rodriguez received a Ph.D. in History from Columbia University and previously taught at Northeastern University, and Boston College. He was a visiting Lecturer at Yale University in 1990 and prior to that was an Adjunct Instructor at City College.

Dr. Matos Rodríguez has authored or coauthored four books, and thirty articles, book chapters, monographs and reviews. He received several fellowship awards and was honored by professional and learned societies in his field. We are pleased to have Dr. Matos Rodríguez at Centro and we hope he has a wonderful tenure at Hunter.

PSC Election Debate

The Faculty Delegate Assembly and the Hunter College Senate are co-sponsors of a PSC Election Debate to be held by the Hunter College Chapter of the PSC on Wednesday, March 22, 2000 from 1-3pm in Room 615 HW. The candidates in the upcoming CUNY-wide election for President of the Professional Staff Congress (PSC) are:

Richard J. Boris-City University Unity Caucus Barbara Bowen-City University New Caucus

Dr. Richard J. Boris, who was first Vice President of the PSC since 1995, became President of the PSC on February 3, 2000 when Dr. Irwin H. Polishook retired. Dr. Boris is a director of New York State United Teachers, the PSC's statewide affiliate, and a delegate to the National Council of the American Association of University Professors. As first Vice President, Boris has participated in contract negotiations, lobbying and campus visits. He has also represented the union before legislative committees and task forces. Dr. Boris, who teaches political science at York College, was elected to chair of its PSC chapter in the spring of 1993 after serving as acting head. While Chapter Chair he led the successful campaign to remove President Josephine Davis from York. He has been a member of the instructional staff since 1973. He previously taught at Dickinson College and was a visiting professor at Indiana University. He earned a B.A. from Hunter College and a Ph.D. from Indiana.

Barbara Bowen is Associate Professor of English at Queens College and the Graduate Center. Both a scholar and an organizer, she is in her second term as Chapter Chair at Queens. With twenty years of experience in the labor movement, Barbara has led a revitalization of the Queens Union Chapter, making it an effective force in fighting retrenchment, winning grievances for members, ensuring timely pay of

adjuncts, and building alliances between staff and faculty. She has helped to make the Union at Queens a powerful advocate for members and a respected political voice. Nationally known as a scholar of Renaissance literature, Barbara is also a teacher, whose commitment to our students has inspired ten years of activism in defense of CUNY.

Professor Avi Liveson, the Hunter College Ombudsperson will moderate the event. We hope you will put aside some time to attend this important event.

Archives & Special Collections

The division of Archives & Special Collections (formerly The Archives Center) was established in 1966 with the aim of collecting documents of historical significance from Hunter College. Commencing with several boxes of records, this unit has evolved into an institutional repository, containing over 1500 cubic feet of historical records.

As the Head of Archives & Special Collections it is the responsibility of Professor Julio L. Hernandez-Delgado to acquire, arrange, prepare indexes (finding aids), and make accessible archival records and manuscript collections to interested scholars and researchers. Professor Hernandez-Delgado invites donations of materials that are directly or indirectly associated with Hunter College. Retiring faculty are asked to consider depositing their papers with the repository. Faculty papers would be organized, preserved, and made available for public use.

The division of Archives & Special Collections is located in East 222-A and is open to the public Monday-Friday from 9:00a.m. to 5:00p.m. Professor Hernandez-Delgado can be reached at 212-772-4149 to answer any questions or concerns regarding the repository and/or any potential donations.

Resolution Adopted by UFS

The following compromise Resolution of CLTs was voted on and adopted by the University Faculty Senate on 2/29/00. It was brought to the attention of the UFS Committee on the Status of Faculty by Ellen Steinberg, Chief CLT at Hunter, in her capacity as Chair of its Sub-Committee on CLTs, and approved by the UFS Executive Committee before being presented for a vote to the body of the UFS.

Ms. Ellen Steinberg believes that students and faculty are better served when staff feels represented and included. It is with this in mind that she has worked for the passage of the Resolution on CLTs. She looks forward to the faculty and administration endorsing the Resolution on College Laboratory Technicians

Whereas, the University Faculty Senate delegates include College Laboratory Technicians (CLTs), and

Whereas, CLTs are not uniformly enfranchised throughout CUNY campuses,

Therefore, Be It Resolved, that the University Faculty Senate recommends the establishment on each campus of a mechanism for CLT representation to departmental and college-wide Personnel and Budget Committees when issues affect CLTs on their appointment, reappointment, tenure, and promotion.

Because You Asked...

Several faculty especially newer faculty and adjuncts have asked about the work of the major governance organizations. We thought we should give you a synopsis.

The Faculty Delegate Assembly

The Faculty Delegate Assembly, composed only of faculty members, was formed to be the organization to express the will of the general faculty. Its membership consists of two faculty members elected by each department, the faculty members of the Administrative Committee of the

Hunter College Senate, the members of the Executive Committee of the General Faculty (who also constitute the Executive Committee of the Faculty Delegate Assembly), and all Hunter delegates to the University Faculty Senate.

As set out in the Bylaws of the General Faculty, the Faculty Delegate Assembly works to know and to articulate matters of academic and social concern to the Hunter Faculty. It has no legislative powers as does the Hunter College Senate, but it can respond to faculty concerns and provide a forum for open consideration of significant issues; out of these discussions. policy may be formulated and passed forward for action by legislative bodies like the Hunter College Senate and the University Faculty Senate. The Faculty Delegate Assembly is the official liaison with the University Faculty Senate in that through the FDA the General Faculty elects a designated number of faculty members to represent Hunter on the University Faculty Senate.

The Hunter College Senate

As the College legislative agency, the Hunter College Senate has policy-making powers in the following areas:

- 1. Curriculum
- 2. Academic requirements and standards
- 3. Instruction and evaluation of teaching
- 4. College development

In addition to its legislative powers, the Senate can express itself formally as an advisory body, transmitting its recommendations to the appropriate authorities.

The Senate operates in accordance with the terms set forth in The Charter for a Governance of Hunter College (available in the Senate Office). Representatives of the faculty, the student body, and the administration constitute the voting membership of the Senate. Regular nominations and elections are scheduled each spring semester.

The elected officers of the Senate—Chair, Vice-Chair and Secretary, together with the Chair of the Evening Session Council—constitute the Senate Administrative Committee.

There are fifteen standing committees of the Senate and a number of ad-hoc and special committees. Membership on committees is open to all faculty and students.

University Faculty Senate

Composed of representatives from all units of the City University, operating under its own Bylaws, consistent with the Education Law and the CUNY Bylaws, the University Faculty Senate formulates policy concerned with the academic status, obligations, rights, and freedoms of the CUNY faculty. It concerns itself with research and scholarly activities relevant to the City University as a whole. It exists apart from and does not involve itself in internal matters of the separate units of the University. Its Chairperson serves on the board of the City University without vote.

In Memoriam

Professor Emerita Carolyn Eisele, a member of the Mathematics Department for fifty years, died on January 15th, 2000, at the age of ninety-eight years. She began her academic career in 1923, and was known as a writer and lecturer on the history and philosophy of mathematics and science of the late nineteenth and early twentieth centuries, with specialization in the mathematical and scientific thought of Charles St. Peirce. She was the author of numerous books and papers on this subject.

Professor Eisele enjoyed a rich and productive life at Hunter, which included an active membership in Phi Beta Kappa, serving as president of the Hunter Chapter and as Senator from the Middle Atlantic District. She also was a founding member of the New York Section of the History of Science Society, and served as chairman and in other capacities. She was the recipient of two honorary doctorates, and innumerable awards and grants from academic societies, including the National Science Foundation and the National Endowment for the Humanities. She was an exceptional human being. We extend condolences to her friends and colleagues.
