Kenneth P. Berkowitz is a health care industry consultant who provides counsel to the industry on a variety of public affairs issues, including Food and Drug Administration (FDA) regulatory matters and prescription drug policy, among others. Mr. Berkowitz was formerly Assistant General Counsel at Hoffmann-La Roche Inc. He also served as Vice President, Public Affairs, Drug Safety and Drug Regulatory Affairs and as a member of the Pharmaceuticals Business Leadership Board. Over his professional career, Mr. Berkowitz has played a substantial role in policy issues affecting the pharmaceutical industry, including patent restoration, health care reform, Food and Drug Administration (FDA) regulatory reform, and product utilization (appropriate use/government controls) issues. In 1992 he chaired the joint PhRMA/BIO Staff Task Force on User Fees that worked with FDA to develop the initial user fee program for prescription drugs, the Prescription Drug User Fees Act (PDUFA). For his valued assistance to the FDA, Mr. Berkowitz received the FDA Commissioner's Special Citation.

Mr. Berkowitz is frequent lecturer on the subject of regulation of prescription drug marketing and promotion. He has spoken on the subject of regulation before major trade, educational associations and business schools and has created various educational and training programs for individual companies as well as the industry generally. He currently lectures at the Rutgers University Graduate School of Management, Center for Management Development and Center for the Study of Pharmaceutical Management Issues. He has also taught at Fairleigh Dickinson University and lectured at the Amos Tuck School of Business, Dartmouth College.

Mr. Berkowitz has served as an officer and Board member for various not for profit, business and professional organizations. He currently serves on the Editorial Advisory Board of RX Compliance, an industry newsletter for compliance issues.

In 2002, Mr. Berkowitz and his son Gregg launched The PharMed Group, LLC and PharMed Placement, LLC, two unique business enterprises formed to meet the pharmaceutical and medical communications industry's freelance and full time staffing needs. Mr. Berkowitz is a graduate of Hunter College (B.A., 1964) and Brooklyn Law School (J.D., 1967). He earned an LL.M. in trade regulation from New York University School of Law (1970).
