Despite this, the Governor is about to announce his new budget and it is important that we all realize that it can be tentative at best until the federal budget situation is resolved. Re: Affirmative Action Impact on Retrenchment Actions Professor Hampton presented the following resolution concerning the 1995 Hunter College Affirmative Action Impact on Retrenchment Actions:	
WHEREAS, the 25 September 1995 College Statement on Affirmative Action Impact Retrenchment Actions states that although "difficult times lie ahead, the College's commitment to the principles of affirmative action and a diverse work force remains strong"; and	110 111 112 113
WHEREAS, 96% of the total number retrenched in June 1995 were from protected categories as this term is defined in the 25 September 1995 Affirmative Action Impact Statement; and	114 115 116
WHEREAS, the trend of retrenchment of members of protected groups is at a rate 50% greater than their representation in the pre-retrenchment work force; and	117 118 119
WHEREAS, the College's full-time work force demonstrates an underrepresentation of protected group members when compared to the actual recruitment pool; and	120 121 122
WHEREAS, the utilization of protected group members is uneven in the college, ranging from heavy concentration in some departments and divisions to paucity in others, thus underscoring the gravity of this problem; therefore,	123 124 125
BE IT RESOLVED, that the depth and breadth of research, teaching, and service are extended by a faculty that is richly diverse and balanced; and	126 127
BE IT FURTHER RESOLVED, that the Hunter College Senate urges the Administration to uphold its commitment to diversity and professional excellence, and to reaffirm its policy of support for members of protected groups in both professional staff, faculty and administrative positions; and	128 129 130 131
BE IT FURTHER RESOLVED, that the Hunter College Senate urges the restoration of personnel in these categories to pre-retrenchment levels as funds become available for new hires.	132 133 134
