	The 221st meeting of the Hunter College Senate was convened at 4:05 PM in Room W714.	1 2

Report by the President:	The following is a summary statement of President Shalala's report to the Senate:	7 8
	The President informed the Senate that the report by the Middle States Evaluation Team has been received, and that it is a favorable report. Copies have been delivered to the Senate Office, and have been placed on reserve in the Library. The President said that one of her favorite parts is the one which describes the Administration as thin, and that she would remind the Senate of this regularly. Students will be pleased with the recommendation that space be provided for a student center. One of our strengths, which is a real tribute to all, is described as "Unbounded energy and enthusiasm of administrators, faculty, and staff with a sincere and evident belief in the value of the institution and their value as individuals who contribute to it."	9 10 11 12 13 14 15 16 17 18
	The team had some concerns and some good ideas. For example, they suggested that we put together a committee to better coordinate all of our cultural international studies programs. Their concerns include: lack of institutional data and lack of equipment inventory, an inadequate infrastructure of support services, and a need for further physical renovation. They made a very strong statement concerning our problems with funding, particularly in relationship to graduate and professional schools. Most of their recommendations require University and State support, and the team recognized that the University and State have no planning process, and that we therefore have no way of fitting our planning process into theirs. We do incremental budgeting, where OTPS is increased by a certain percentage. They also recognized that we have a very disciplined planning process for the Capital budget, where a University as well as a State planning process is in place. The President said that she will take the entire report to the State and integrate our recommendations into the Middle States report. In general the report is very favorable report with no fundamental problems in the institution. The team praised the academic programs and the innovations that are going on. President Shalala urged everyone to read the report. She said that she would like to discuss the various parts of the report with the Senate at an appropriate Senate meeting. 	President Shalala concluded her report by announcing that new telephone directories will be distributed very shortly. The first page of the directory will provide a listing of emergency numbers for every campus. b. Asbestos Watch

Prof. Sidel yielded the floor to Prof. Jack Caravanos, who informed the Senate that the removal process has begun on the 11th floor and that warning signs have been put up. The area will be tightly sealed and maintained 24 hours a day as required by the contract once the actual removal begins. He further informed the Senate that a serious problem has arisen concerning small repair work at Hunter. The unions, including DC 37, are quite concerned about their members doing asbestos clean-up. This has put a halt to small repair work at Hunter until the union works out its position. Prof. Caravanos said that he would report in more detail at the last Senate meeting of the term.
